September 8, 2020

1. CALL to ORDER and PLEDGE of ALLEGIANCE

Chair, Steve Weiss, called the meeting to order at 7:00 p.m. and led the pledge of allegiance.

2. ROLL CALL

3. APPROVAL OF MINUTES - July 6, 2020

<u>ABSENT</u>

Gary Jacobs (E) Adriana Van der Graaf (E) Julie Mino (E) James Flickinger Robert Trimborn moved to approve the July minutes and Bruce Hamous seconded the motion. Steve Weiss abstained. All others voted in favor and the motion passed unanimously.

4. PUBLIC COMMENT - Citizens wishing to speak to the Commission on an airport related item must fill out a speaker card and submit it to the secretary. Comments will be limited to a maximum of **three** minutes per item.

Speaker cards for issues <u>NOT</u> on the agenda must be submitted <u>before</u> the end of the public comment period.

Speaker cards for issues listed on the agenda must be presented before the item is up for consideration. Speakers will be called when the item is presented.

Mark Sullivan inquired about whether Air 7 is being developed as an Amazon air cargo facility and whether all or part of the CloudNine hangars will be used by Amazon. Mr. Sullivan is concerned about the impact to the public if there were to be an increase in cargo operations at Camarillo Airport. He requested that the Commission seek answers to his inquiries.

5. **NEW BUSINESS**

A. <u>Subject</u>: Receive and File a Summary of the Tenant Workshop Held on August 25, 2020 for the Oxnard Airport Runway 7-25, Taxiway Connectors, and Parallel Taxiway Pavement Reconstruction Project.

Recommendation:

Staff requests that your Commission/Authority receive and file a summary of the tenant workshop held on August 25, 2020 for the Oxnard Airport Runway 7-25, Taxiway Connectors, and Parallel Taxiway Pavement Reconstruction Project.

Director Kip Turner introduced the item and stated that projects administrator Erin Powers would provide additional information. Ms. Powers shared that Mead & Hunt, Inc. led the tenant workshop that took place on August 25, 2020. The purpose of today's presentation is to share a summary of the workshop including feedback that was received, and to answer any questions Commission members may have about the project. Ms. Powers introduced Chuck McCormick who is the project manager with Mead & Hunt, Inc. Mr. McMormick introduced his team at Mead & Hunt, Inc. who includes Jeff Leonard/Principal-in-Charge, Jannet Loera/Civil Design Lead, and Alex Radovanovich/Civil Engineer. Mr. McCormick and team went over a PowerPoint presentation outlining the project

overview/description and phasing options. Mr. McCormick and team, and airport staff responded to general questions posed by Commission members. Mr. McCormick shared that future workshops are planned in the October and January timeframe.

Bruce Hamous moved to approve staff's recommendation and Maggie Bird seconded the motion. Steve Weiss abstained. All others voted in favor and the motion passed unanimously.

B. <u>Subject</u>: Approval of, and Authorization for the Director of Airports or his Designee to Execute, the Fifth Amendment to Lease with Fresh Concepts, LLC to Expand the Leased Premises.

Recommendation:

Staff requests that your Commission/Authority recommend that the Board of Supervisors:

Approve, and authorize the Director of Airports or his designee to execute, the Fifth Amendment to Lease with Fresh Concepts, LLC (Fresh Concepts) for additional area to be added to the leased premises.

Director Kip Turner introduced the item and stated that lease manager Madeline Herrle would provide additional information. Ms. Herrle shared that the lease amendment allows the Waypoint Café located at Camarillo Airport the ability to expand their outdoor seating area. The expansion is needed to comply with social distancing requirements related to the COVID-19 pandemic.

Bobby Williams moved to approve staff's recommendation and Maggie Bird seconded the motion. Steve Weiss abstained. All others voted in favor and the motion passed unanimously.

6. UNFINISHED BUSINESS

A. <u>Subject</u>: Review Proposed Amended Bylaws of the Ventura County Aviation Advisory Commission and Recommend Adoption by Board of Supervisors.

Recommendation:

Staff requests that your Commission review proposed Amended Bylaws of the Ventura County Aviation Advisory Commission and recommend to the Board of Supervisors that it adopt by Resolution the proposed Amended Bylaws.

Director Kip Turner introduced the item and he reported back on two action items that Commission members requested further clarification on during the December 2019 meeting. Commissioner Robert Trimborn provided background on the bylaws revision process. Mr. Trimborn shared that the revised bylaws document in the meeting packet is essentially the same document that was reviewed by the Commission during the December 2019 meeting but he pointed out that the formatting has changed. He also pointed out that procedural language was added which can be seen in the redlined version in the packet.

Robert Trimborn moved to approve staff's recommendation and Bruce Hamous seconded the motion. Steve Weiss abstained. All others voted in favor and the motion passed unanimously.

7. DIRECTOR'S REPORT

Director Kip Turner shared an updated on the Aspen Option Agreement which was approved by the Aviation Advisory Commission on July 6, 2020 and by the Oxnard Airport Authority on July 9, 2020. The Option Agreement was scheduled to go before the Board of Supervisors on July 28, 2020 however Mr. Turner pulled the item from the Board's agenda for further vetting. Mr. Turner also shared that RKR, Inc. experienced delays with the CloudNine Project related to COVID-19, and their current Option Agreement was set to expire on September 10, 2020. Due to the time-sensitive nature of this matter, an extension to the current Option Agreement went before the Board of Supervisors on September 1, 2020. The Board approved an extension to March 10, 2021.

Director Turner shared that he anticipates bringing the hangar lease item before the Commission on November 2, 2020, the Camarillo and Oxnard Airport Authorities on November 12, 2020, and the Board of Supervisors on December 8, 2020. Mr. Turner reminded the Commission about the Department of Airports' plan to move forward with the master plan study for both Camarillo and Oxnard airports. The department has now received a full grant in the amount of \$750,000 for this effort. There will be extensive public outreach including public workshops. More information will be shared at future meetings.





From time to time at our airports, situations arise that require assistance in some capacity. The Department of Airports will normally have the ability to report in a support role to your location quickly during our normal operating hours. We are glad to receive that call for assistance, but we also want you to know what you can expect from our team when they respond.

The primary role of the Department and our team is the safety and security of the airport. When we respond to your call for assistance, our team will quickly diagnose the situation and, if not already called, will assist by calling additional support such as emergency services (police or fire departments) as warranted. Those outside support agencies such as Police and Fire are the dedicated agencies and individuals who have the authority and training in conflict resolution and in life saving protocols to properly handle such situations. Our team will assist in any way they can as per their training however their primary role is to ensure the Airport remains a safe and compliant environment thereby ensuring the safety and security of the airport overall.

Once the situation has been resolved or is no longer a safety hazard in any manner, they will gather information from all parties and generate an incident report that documents events as observed.

In response to your letter dated August 18, 2020 and your request for a response by August 31 2020, we address your questions as we have to your agent Mr. Kirschenstein on several previous occasions.

In contrast to your statement that the Department of Airports "...have retreated from its interest without explanation", the Department of Airports ("DOA") has indicated the following information on several occasions, most recently via email from Kip Turner to Joel Kirschenstein on May 27, 2020. DOA maintains an interest in acquiring these properties, and has listed these locations for Airport Improvement Program (AIP) funding when available. The AIP grants that we are eligible to receive are based on the priority of the Airport's needs, which now are focused on runway projects. Given the significant need for the two runway projects at both airports and their priority, the DOA would need all available funding to go to those projects first, and we would not be able to support any request the OUHSD would attempt to make directly to the FAA to receive funding from our entitlements or discretionary funding prior to the completion of the two runway projects.

The DOA is in the final design for the runway reconstruction at OXR for construction to start as early as June 2021 and the Camarillo Airport runway will follow directly after that, so we anticipate all available AIP funding being devoted to those two projects for approximately 5 years. Following that work we would be interested in resuming our discussion about funding and acquisition of these properties.

With respect to the potential uses in an RPZ area, the FAA provides the following guidelines (in italics):

Mr. Jeff Weinstein August 31, 2020 Page two

For RPZ land, the following land uses are permissible without further evaluation: (1) Farming that meets airport design standards. (2) Irrigation channels that meet the requirements of AC 150/5200-33 and FAA/USDA manual, Wildlife Hazard Management at Airports. (3) Airport service roads, as long as they are not public roads and are directly controlled by the airport operator. (4) Underground facilities, as long as they meet other design criteria, such as RSA requirements, as applicable. (5) Unstaffed NAVAIDs and facilities, such as equipment for airport facilities that are considered fixed-by-function in regard to the RPZ.

This doesn't mean another use could not be considered, but would be subject to FAA's review. Generally speaking the criteria is for there to be no human occupancy.

Finally, the reference you use as the "Airport Authority" is not correct; the Ventura County Department of Airports would be the correct reference.

Thank you for the opportunity to respond to your concerns.

We are in the process of developing the CSPP for the Runway 7-25, Taxiway Connectors, and Parallel Taxiway Pavement Reconstruction Project at the Oxnard Airport. Attached is an exhibit detailing a potential construction phasing alternative for the Project and we would like to solicit the FAA's input.

A brief description about the alternative:

- Convert Taxiway F into a 60-foot wide temporary Runway 7-25
- Since Taxiway F is 75 feet, the 60-foot runway would not have a centered crown as it will be pushed to the north edge to have more distance to the hangars on the south
- Some hangars will be slightly within the ROFA
- Some hangars will be within the Primary Surface
- Small aircraft (B-I) with approach speeds of 50 knots or more would be able to use the temporary runway
- There will be direct access between apron and runway ends
- ASOS and glide slope antenna will be inside the Object Free Zone Area
- There are some isolated locations near Taxiway C where transverse slopes are less than 1%

Due to the items listed above, Mead & Hunt feels this alternative is not feasible from a safety perspective, but would like to request the FAA to provide a determination.

The County has requested your response by close of business on Friday to help keep the project design on track.

Hi Jannet,

As noted during our review, the proposal has hangars in the ROFA, other structures in the RPZ, confusing geometry along with other airport standards issues. As a result, utilizing parallel Taxiway F as a temporary runway alternative would significantly increase the likelihood of Runway Incursions and decrease safety. The alternative as proposed is <u>unacceptable</u> based on our cursory review.

We are open to considering other alternatives. Proposals utilizing the taxiway as a runway would likely require lengthy reviews and potentially required a Safety Risk Management Panel (SRMP) and still could be found to be unacceptable due to OXR Airport's existing geometry.

Dear Mr. Moe,

The County of Ventura – Department of Airports (DOA) has reviewed the subject subdivision application and offers the following in support of the determination. We find the application to be incomplete and would like to submit the following comments.

In the Project Information Section, Question 1, DOA requests that the applicant identify the current M-1 Zoning and discuss how the project conforms to the M-1 zone. We understand that the applicant is proposing retail, which could impact Level Of Service (LOS) for the intersection of Airport Way and Pleasant Valley. DOA believes the proposed retail development portion of the project should include a traffic analysis study prior to further consideration for this type of use to ensure existing LOS for roadways and intersections impacted by the development are maintained.

In the Project Information Section, Question 2 and Question 4, DOA requests that the applicant acknowledge the DOA has maintained vital aeronautical equipment on the water tower located on the subject property. DOA requests that the developer work with DOA to dedicate an easement to DOA conveying rights to continue to access and maintain said equipment, an easement which shall run with the land. Acknowledgment of that easement shall be recorded and made a part of the subdivision documents.

In the Project Information Section, Question 3, DOA requests that the applicant address traffic impacts specifically. Stating that traffic "is expected to be from within the airport" does not appear to be a complete assessment of potential impacts to the LOS at multiple intersections, especially in light of the proposed retail uses. Please reference our comments on Question 1.

In the Project Information Section, Question 4, DOA requests that the applicant state that the applicant shall work with DOA to dedicate a new avigation easement that conveys certain rights to DOA to limit the height of structures and to limit other uses that could be considered hazards to air navigation. Such an easement will run with the land and bind future owners within the subdivision to the terms of the easement.

In addition, because streets and some utilities within the Airport Business Park are private, DOA requests that the applicant participate in the maintenance of these interior roadways and utility facilities. The applicant and subsequent individual owners of subdivided parcels within the subject property should be made aware that their parcel is within the Airport Business Park and state that owners shall cooperate with DOA to provide for the shared maintenance and regulation of the private roadways and common utilities within the Airport Business Park.

Project Description

The Runway 7-25, Taxiway Connectors, and Parallel Taxiway Pavement Reconstruction Project (Project) consists of reconstructing the runway, taxiway connectors, and parallel taxiway at the Oxnard Airport located at 2889 W 5th Street, Oxnard, California 93030.

The minimum acceptable level of serviceability for the Oxnard Airport runway has been reached or is no longer cost-effective to perform maintenance activities on the pavement.

To bring the Oxnard Airport's runway to current standards will require reconstructing the runway, taxiway connectors and parallel taxiway.

This effort will require the removal of existing pavement surface, construction of new pavement, shoulder work, application of pavement markings, installation of underdrain system, electrical facilities, new edge and MALSF lights, and new signage, as well as modifications to the existing storm drains.

Ampaire's Electric EEL Skymaster Makes Longest Flight Yet

Electric propulsion systems developer Ampaire last week achieved its longest flight with the Cessna 337 Skymaster that it has converted to hybrid-electric power. On October 8, the six-seat, Electric EEL aircraft took off from the Los Angeles-area Camarillo Airport and made a 341-mile flight to Hayward Executive Airport in the San Francisco area in 2 hours and 35 minutes. Ampaire, claims this was the longest flight to date for what it defines as a "commercially relevant" aircraft using electric propulsion.

The Electric EEL is powered by a 310-hp Continental IO-550 engine installed in the tail of the aircraft and a 130-kW electric motor in the nose. According to Ampaire, the piston engine powered all taxiing, and then a combination of it and the electric motor were used for takeoff and climb. The cruise phase was mainly powered by the piston, while the motor was put in low power mode, before being switched to idle during descent and landing.

The company did not answer questions from **AIN** about how much fuel was consumed during the flight or provide any details about payload weight. The batteries for the electric motor are attached to the underside of the fuselage in a composite nacelle.

The flight was piloted by test pilot Justin Gillen and flight-test engineer Russell Newman, the flight averaged 135 mph as it traversed California's Central Valley at an altitude of 8,500 feet. "The mission was a quite normal cross-country flight that we could imagine electrified aircraft making every day just a few years from now," said Gillen. Normally the Cessna 337 can cruise at up to 190 mph and Ampaire said its pilots had opted to make "conservative" use of the electric motor "to optimize for a specific battery state of charge upon landing."

The demonstration took place little more than a year after the first EEL made its first flight, and just four weeks after this aircraft, the second in the program, took to the skies. Known as the Hawai'i Bird, this airframe will now be partially disassembled at Hayward and shipped to Hawaii to take part later this year in a series of proving flights with Mokulele Airlines on its short-haul routes. That test program will be partially funded by Elemental Accelerator, a green-technology financial support platform.

"The trial flights with Mokulele will not only demonstrate the capabilities of the EEL but will help to define the infrastructure required for wide adoption of electric aviation by airlines and airports," said Ampaire general manager Doug Shane, adding "the ability to put innovative electric technologies into the air rapidly to assess and refine them is central to Ampaire's strategy to introduce low-emissions aircraft for regional airlines and charter operators within just a few years."

According to the company, the EEL can cut fuel use and emissions in half on shorter routes where its electric powerplant can run at higher power settings and generate similar reductions of up to 30 percent on longer regional routes such as Camarillo to Hayward.

The Electric EEL program is viewed as just a stepping stone toward a larger goal, said company CEO Kevin Noertker. "Our next step will likely be a 19-seat hybrid-electric retrofit program that will lower emissions and operating costs, benefitting regional carriers, their passengers, and their communities," he explained. "Ampaire, with funding from NASA and others, is in the midst of design studies for such an aircraft based on the de Havilland [now Viking Air] Twin Otter aircraft. That hybrid-electric aircraft will be called the Eco Otter SX."
