# C. <u>Subject</u>: Receive and File a Staff Report Outlining Skydiving Operation Tests and Potential Future Operations at Oxnard Airport

#### Recommendation:

Receive and file staff report outlining skydiving operation tests and potential future operations at Oxnard Airport.

Keith Freitas, Director of Airports, prefaced this item with the history between the Department of Airports and Skydive Coastal also known as "I Sky Dive". Casey Pullman, Deputy Director of Airports, presented this item detailing the planned trial period. Comments and questions regarding landing zones and distractions to drivers on the major roads in Oxnard were welcomed and addressed. All factors are under consideration and the objective is to be a safe running airport.

D. <u>Subject</u>: Approval of, and Authorization for the Director of Airports or His Designee to Sign, Contract Change Order No. 4 in the Not to Exceed Amount of \$1,000,000 with Security Paving Company for the Reconstruction of Taxiway F (renamed A) at Oxnard Airport, Raising the Total Contract Amount from \$18,433,590 to the Not to Exceed Total Amount of \$19,433,590; Project Specification DOA 23-03 and Project No. OXR-150

#### Recommendation:

Staff requests that your Commission/Authorities recommend that the Board of Supervisors (Board):

Approve and authorize the Director of Airports or his designee to sign, Contract Change Order No. 4 (Exhibit 1) in the not to exceed amount of \$1,000,000 with Security Paving Company

for the reconstruction of Taxiway F (renamed A) at Oxnard Airport, raising the total contract amount from \$18,433,590 to the not to exceed total amount of \$19,433,590.

Erin Powers, Projects Administrator, presented this item for its recommended approval by the Board of Supervisors. Contract Change Order No. 4 will utilize the current contract for the removal and disposal of excavated soil from a prior phase of Taxiway reconstruction. The stockpiles are expected to be removed during the January – February time frame. More information as to the stockpile findings can be accessed through a public records request. The Authorities appreciate the transparency the Department of Airports has bestowed to the community on this project.

Oxnard Airport Authority: Upon the motion of Councilmember Bert Perello and seconded by Vice Chair Gabe Teran, the Authority hereby approves the recommendation as stated in the respective agenda letter for Regular item 7.D. All members voted and the motion passed unanimously 5-0.

# 8. DIRECTOR'S REPORT

Director Keith Freitas opened the Director's Report by thanking elected officials from the City of Camarillo and Board of Supervisors. Together they did a fabulous job and should be recognized for their coordinated efforts during the Mountain Fire. The report continued by exemplifying Camarillo Airport's role during the Mountain Fire. During the five-day closure, the first two days operations were running 24-hours. Up to twenty helicopters aiding in firefighting efforts were stationed at Camarillo Airport. In addition to helicopters, Camarillo Airport established itself to support various vehicles such as fueling vehicles, fire retardant vehicles, food and sleeping quarters for first responders.

On October 29<sup>th</sup>, Communications and Engagement Manager Jannette Jauregui provided email notification regarding the development sites at Oxnard Airport. During the regular developmental/environmental processes, the developer found that a portion of the five-acre parcel had elevated levels of pesticides. Development discussions at Oxnard Airport are shut down while the Department of Airports proceeds with hiring an environmental consultant. The environmental consultant that conducted the analysis and the County of Ventura Environmental Health determined there is no immediate concern to the public. The information was shared with the Oxnard community, and elected City officials out of an abundance of caution. The Department of Airports initiated the process of hiring an environmental consultant to provide additional testing and analysis to recommend remediation efforts, if needed.

The Department of Airports wrapped up its public meetings for the Part 150 Noise Study on October 7<sup>th</sup> for Camarillo and October 8<sup>th</sup> for Oxnard. The Camarillo Airport meeting held at VCOE had approximately ninety people in attendance. The Oxnard Airport meeting had approximately twenty-five people in attendance. In summary, the biggest concerns for the Oxnard community were land uses around the airport, and for the Camarillo community is the jet arrivals over Old Town Camarillo. For the first time in the two-year process Camarillo community members gave a round of applause at the conclusion of the presentation. The

final public hearing on the Camarillo and Oxnard Airports Part 150 Noise Study documents are tentatively scheduled for April 7<sup>th</sup> and 8<sup>th</sup>.

Camarillo Airport hosted the annual Ventura County Sherrif's Foundation Coppers and Choppers event on September 21<sup>st</sup>. The event featured Sheriff's deputies, K-9 units, mounted patrol, search and rescue, marine operations, bomb/arson unit, SWAT, and up close and personal viewing of various law enforcement vehicles and helicopters.

Camarillo High School held its military appreciation night during the varsity football game on September 13<sup>th</sup>. At their request and arrangement, a formation of three T-6 aircrafts flew over the football field before the start of the game. The aircrafts then did a low pass at Camarillo Airport before departing the area. Inquires as to the T-6 aircraft formation came in from community members, including a call from Camarillo Mayor Tony Trembley. The event was later clarified to the community and were understanding and supportive.

"Doc" is one of two air worthy B-29's in the world, and visited the Commemorative Air Force hangar/museum at Camarillo Airport. Tours were provided to the public while it was parked here last month.

The final pavement marking application on Runway 8-26 and Taxiway A at Camarillo Airport was completed in approximately a weeks' time. The emergency repairs to the runway and taxiway were needed as it buys time for Camarillo Airport's ultimate reconstruction which will be in approximately seven years.







Below is a summary of the tasks completed by Woolpert during the month of October 2024 for the Camarillo Airport:

#### Conceptual Design for Runway/Taxiway Reconstruction (County Project No. AEA 22-10)

- Throughout the month of October, the County and Woolpert discussed this project during coordination meetings on October 3, 17, and 31, 2024.
- Upcoming:
  - County to provide comments on the Conceptual Design package.

#### Final Design for Runway Reconstruction (AIP Project No. 3-06-0339-044-2024)

- Throughout the month of October, the County and Woolpert discussed this project during coordination meetings on October 3, 17, and 31, 2024.
- On October 15, 2024, Woolpert and the County held a meeting to discuss the design survey schedule and scope. The design survey was scheduled to coincide with the runway closure for the Runway 8-26 and Taxiway A Pavement Improvements project from October 21-23, 2024 within the Runway Safety Area (RSA) and October 24-28, 2024 outside of the RSA.
- On October 18, 2024, Woolpert provided a summary of the design survey schedule to the County.
- On October 21-28, 2024, Woolpert's survey team completed the topographical design survey within the project limits.
- On October 22, 2024, Woolpert and the County coordinated on the request of Earth Systems Pacific, the geotechnical investigation firm, to mark private utilities and boring locations in the next few weeks, as well as to schedule the coordination meeting to further discuss the geotechnical investigation schedule and scope.



# Camarillo Airport Plays Vital Role in Fighting Mountain Fire

Widespread blaze began on Wednesday morning and quickly grewpushed by Santa Ana winds.

amarillo Airport (KCMA) in Ventura CountyCalifornia, is playing a vital role in the efforts to extinguish the Mountain Fire. The wildfire began on Wednesday morning and quickly grewpushed by Santa Ana winds.

The airport is being used as a base for the aerial defense aircraft, which may increase to 28 in all by this evening, according to Ventura County spokesperson Jannette Jauregui.

Fire officials held a press conference Thursday morning, describing the blaze as 0 percent contained as of 11 a.m. PSTThe airport is not directly threatened by flames, but that could change, Jauregui said.

According to officials, waterdropping helicopters worked throughout Wednesday evening, which is unusual for fires of this nature. In addition to the helicopters, hundreds of fire trucks were on site pumping water on the flames.

The resources come from several government agencies, including the Ventura County Fire Department, California Department of Forestry and Fire Protection (CAL FIRE), U.S. Coast Guard, Orange County Fire Department, Los Angeles County Fire Department, and Coulson Aviation, in addition to local law enforcement.

Jauregui said smoke is a major challenge because it reduces visibiliţwhich hampers the flight crews.

"There is a TFR[Temporary Flight Restriction] in place, and the airport will be closed to nonemergency aircraft through Wednesday of next week to allow emergency crews to safely navigate the airspace," she said. "This closure will allow emergency response aircraft—helicopter and fixed wing—to utilize Camarillo Airport as a base for all firefighting aerial units."

She added that the county is in communication with airport tenants to keep them apprised of the situation.

The TFR is in place through November 13 but may be extended.

"Conditions will continue to be impacted by Santa Ana winds, which are expected to continue through this afternoon," Jauregui said. "Oxnard Airport [KOXR] is currently outside the TFR and remains open."

Officials reported last night that the fire was moving southwest. By Thursday morning, it began to move east as the winds shifted. Fire crews are focusing on protecting human life and structural defense as embers from the flames are being carried more than 3 miles by the winds and landing in the tindedry conditions.

More than 14,000 evacuation notices have been issued, and several buildings have been lost to the fastmoving wildfire. As of Thursday afternoon, exact numbers are not available, as fire officials noted the situation remains "active and unpredictable."

No injuries have been reported at this time.

This message serves as notification that a NOTAM (Notice to Air Mission) has been issued for Camarillo Airport (CMA) indicating the CMA will be closed to all non-emergency response aircraft and operations through Wednesday, November 13<sup>th</sup>, at 4 p.m. This closure will allow emergency response aircraft (helicopter and fixed wing) to utilize Camarillo Airport as a base for all firefighting aerial units.

Additionally, a TFR (Temporary Flight Restriction) has been implemented for the areas impacted by the Mountain Fire. (Please see attached map.) This TFR is in place through November 13<sup>th</sup> and will ensure that emergency response aircraft, including all firefighting units, can safely and effectively navigate airspace to complete aerial attacks on the fire.

As you know, the Mountain Fire has devastated more than 14,500 acres in just a little over 24 hours. The fire is at 0% containment as of 10 a.m this morning. This means that both the closure of CMA and the TFR may be extended. As of today, fire response resources include the Ventura County Fire Department, Cal Fire, United States Coast Guard, Orange County Fire Department, and Los Angeles County Fire Department, and Coulson Aviation. We are expecting to support approximately 28 firefighting aircraft during this response. Conditions will continue to be impacted by Santa Ana winds, which are expected to continue through this afternoon. Oxnard Airport (OXR) is currently outside the TFR and remains open.

The Department of Airports continues to send well wishes to all emergency response teams, to our neighbors, and to our entire aviation community. We understand that many of you have been directly affected by the Mountain Fire as we all only just begin to understand the toll this has taken on so many families.

## Mountain Fire: A Community Response Beyond the Flames



The morning of Wednesday, November 6<sup>th</sup>, found most of us in our normal weekday routines. Kids were in school. Their parents were at the office. Some were simply enjoying a morning inside their home to escape the high winds and the red flag warnings that the National Weather Service labeled as "a particularly dangerous situation."

No one who lived through the Thomas Fire in 2017 was ignorant to the damage those winds could cause. Still, we carried on with our mornings. After all, there were meetings to attend, errands to run, and to-do lists to tackle.

It's safe to say that when news spread that a fire broke out on the mountainside in Somis that morning, we all held our breath. And though many of us experienced firsthand how quickly the Thomas Fire ravaged through communities, there is no way we could have been fully prepared for the minutes, hours, and days ahead.

Trying to capture the devastation so many Ventura County residents experienced from what became the Mountain Fire, and the impact that devastation has had and will continue to have, is nearly impossible.

In the middle of that devastation are the footprints of the first responders who worked in some of the worst possible conditions to save lives and save homes that the fire had yet to reach. And on the hillsides covered with burn scars are the remnants of the phos-chek drops by the aerial defense operations that flew almost around the clock until containment of the fire was under control.

Based at Camarillo Airport since 1971, the Ventura County Aviation Unit was literally in the backyard of the Mountain Fire. High winds made it difficult for aerial defense operations, but the Unit was still able to complete water drops, essentially flying through the entire first night to battle the flames.

Eventually joined by countless additional resources including Cal Fire, Coulson, and Santa Barbara, Montecito, Glendale, Orange County, and Burbank fire departments, containment of the fire, which burned nearly 21,000 acres, went from zero percent Thursday to 26 percent by Sunday.

Seventeen aircraft were on hand at Camarillo Airport at the peak of the fire with aerial defense depending solely on helicopters. Conditions were simply too unsafe for fixed wing aircraft to fly. More than 2,200 emergency response personnel were both on the ground and in the air. The Ventura County Aviation Unit alone performed 300 water drops, which equates to 200,000 gallons of water. The high frequency of the drops, and the quick turnaround time of each aircraft between drops, was made possible by the close proximity of Camarillo Airport, which closed for the incident to become a full-fledged aerial defense response base for five days.

Having Camarillo Airport as a resource is a "game changer," according to Ventura County Fire Battalion Chief, Nick Cleary, who served as Operations Chief for the Mountain Fire. He added that the logistics of having to move aircraft to a different, more distant airport to refuel, repilot, and maintain aircraft would have resulted in a significant loss of time.

"Camarillo Airport has been a fantastic resource," said Ventura County Sheriff Sgt. Kelly Roark. "Quick turnaround for aircraft involved in firefighting is critical for public safety. Having a safe and secure location for personnel assigned to those aircraft is also very important."

While the wildfires in Ventura County have made headlines nationally, it's really the community's response that is the story. The calls to action that are answered without hesitation. The doors left open for those who lost their home. The shelters that became available for animals. The clothing and food donations. The hand drawn thank you notes to firefighters from the child whose home was saved. And the simple act of a hug when you aren't even sure yet of what it is you need.

Many of those stories will remain unknown. What we do know is that amid the uncertainty of a wildfire in Ventura County lies the certainty that a team of highly trained first responders is nearby to provide the sense of relief we all felt that first night of the Mountain Fire as we watched rig after rig drive toward the fire and heard the continuous hum of helicopter after helicopter providing aerial support.

In the end those affected most are neighbors, family members, colleagues and friends. And they are also the first responders who are on rigs or who are flying to stop a fire that robbed them of their own home.

# **Chaos and devastation: How the Mountain Fire erupted**

Samah Naim peered out the window of her Somis kitchen in flip-flops and pajamas. Fire flew through chaparral and up the driveway, her driveway.

She screamed.

It was 9:22 a.m. Wednesday. The Mountain Fire that ignited 3 miles away was sweeping across Somis in a sprint accelerated by 80 mph Santa Ana winds that rattled the small ranches on their Ridgecrest Lane cul-de-sac.

The fire soon leaped to the hills above Camarillo where it fed on more homes. It destroyed some 243 structures and threatened thousands more. In its first hours, the assault triggered roadside rescues, firefighters racing to get ahead of the flames and people scrambling to escape.

Hatim Naim, Samah's husband, called 911, yelling that the fire was close. They raced into the garage with their eldest son, Ehab. The power was out. Their cars were trapped.

Ehab ran back into his house and led the way outside into a morning blackened by smoke but still glowing with fire. They ran to the one car parked outside, yelling as they threw themselves inside.

They drove up the driveway to Ridgecrest, the car pummeled by winds as it speared directly across the flames to safety. Hearts pumping, they drove on.

On the way to the Camarillo Family YMCA, they received an evacuation alert. It came too late. Their house – uninsured because premiums were \$19,000 a year – was gone. So were

their passports, three cars, clothes bought for their son's December wedding and everything else they owned.

## Burning 2,000 acres an hour

Heading into Wednesday, forecasters warned of extremely critical fire weather amid "particularly dangerous" Santa Ana winds. The Ventura County Fire Department had added 100-plus personnel on duty.

Dispatch got the call about a fire growing fast near Balcom Canyon at 8:51 a.m.

In a hangar at the Camarillo Airport, pilot Kristopher Tamburello and his crew had just finished their initial checks. He took off and dipped into an agricultural pond near the end of the runway to load up with water. Another helicopter lifted off just after him.

"As soon as we lifted, we could see the header of smoke," Tamburello said.

The Firehawk pitched with the winds as they flew along the edge of a column of smoke. Flames already raced toward ranches and homes as they dropped their first 600 gallons of water next to one house.

The fire pushed out like fingers, spreading across the valley and through ranches, fields and islands of eucalyptus trees. It was moving 2,000 acres an hour, Ventura County Fire Chief Dustin Gardner said.

He called departments throughout the region asking them to send help immediately.

"I'm going to start losing lives," he told them.

# A truck catches fire

Kim Lucien could see fire to the right, so she turned left, pulling her friend's three horses in a trailer behind her truck.

As she drove on Bradley Road near Somis, flames licked the bottom of fence posts and the smoke got thicker. Embers blew past like a hot hail storm, one hitting her windshield with a loud thunk. She pressed harder on the gas.

When the smoke seemed to clear, she took a breath.

"Oh my God, I made it," the Moorpark woman remembered thinking, just before warning lights flashed on her dashboard. Her truck slowed, then stopped. She didn't see the flames engulfing the engine until she jumped out.

When she saw a red truck, she waved her arms. The firefighter inside called for an engine. His fire extinguisher bought enough time to get the horses out.

With her truck doused, the firefighters moved onto the next call. Ventura County sheriff's deputies stood with Lucien on the side of the road, everyone taking turns holding onto a horse.

Lucien scrambled to text and call anyone she could think of with a trailer, knowing the spot was still in the fire zone. Then, one just pulled up. Two women headed to pick up horses got turned around by flames.

They loaded up Lucien and the three horses and took off.

# 'My heart sank'

Near the spot where Highway 118 and Aggen Road meet, county fire Division Chief Barry Parker scouted an area to hold the line. The fire was still a couple miles away. The plan was to stop it before flames crossed the highway.

Over the ridge south of the 118, neighborhoods line craggy ravines above Camarillo. The wind howling, Parker looked up at the hill. A small spot lit up in the brush. In seconds, one became many, as flames raced uphill.

"My heart sank because I knew what that meant," Parker said.

He called over the radio that the fire had jumped – some 2.5 miles ahead of itself, officials would later say – and he hit the gas. His lights flashed through thick smoke as his truck climbed the narrow roads toward the Las Posas Estates.

The fire beat him there.

He called for 10 strike teams - 50 engines - to head his way. He knew he would need them and knew the number was more than would be available.

The fire would hit Camarillo Heights first, a little farther east than Las Posas Estates, and firefighters there also would need help.

"Send me anything that you have," he told the operations chief.

## Too scared to move

The wind whipped so hard shingles flew off roofs at the top of West Highland Drive in Camarillo Heights. Tom Wilson braced himself as he looked out from the ridge toward Highway 118. The smoke was still miles away.

Feeling safe for the moment, he steered his truck back down the narrow, winding road. The smoke grew thicker with each turn.

By the time he made it to his rented two-bedroom home closer to the bottom of Highland, he could feel the heat. The fire had jumped from Somis to the hills above Camarillo. It was hurtling toward his home.

Some of his neighbors received evacuation alerts. Wilson's phone was silent. Still, he knew he had to leave.

His wife, Amanda, wasn't feeling well. She stayed home that day with their 15-month-old son, Koe. Amanda's mother came to pick up the boy. Wilson threw baby clothes and a few of Koe's toys into Amanda's car and then sent her out too.

He stayed longer. He opened the gate for his Nigerian dwarf goats and tried to shoo them out of a pen. They huddled together, too scared to move.

Wilson finally left, driving down Highland and past the firefighters at the bottom of the hill. It was 11:46 a.m. Three minutes later, cameras set up outside the home showed the house was on fire.

It was destroyed. Eight of his goats died.

"These are my babies," he said. "They were part of the family."

# **Multiple homes burning**

Crews rushed to Camarillo Heights before the fire jumped Highway 118, but once it did, almost every engine was pulled to the hillside neighborhoods, Gardner said.

"There were multiple homes on multiple levels burning across the heights," he said. "People who didn't leave or couldn't leave their homes, we were putting in fire trucks, or putting in police cars, or putting in whatever we could get them in."

Some engines drove with lights and sirens up from Los Angeles. Others came from Santa Barbara, Kern and Orange counties. Gardner and his deputy chief scouted locations to send them as soon as they pulled off the freeway.

"They were going direct to search and rescue," Gardner said.

# **Roads jammed with evacuees**

In the Las Posas Estates, Parker couldn't see more than 5 feet in front of his truck. As each engine called in, he sent them to the next road or 911 call.

It would be hours before they took the offensive, fighting the fire. They worked to save homes when they could, the department said. But the priority was getting people out of the way.

On Valley Vista Drive, bumper-to-bumper traffic inched along the two-lane road jammed with evacuees. Sheriff's deputies and firefighters waved drivers toward other routes. Otherwise, cars would have been trapped.

"Minutes mattered. Seconds mattered," Parker said.

His truck filled with smoke as he rolled down his window to tell a woman she needed to leave. He walked her to her car, but one of her back tires was already on fire.

He drove her to the closest fire station, dodging tree limbs, downed wires and garbage cans. He flipped his wipers on and off, trying to knock off embers.

# 'Just keep going'

Just before noon, Candy Lingl drove up her street in the Las Posas Estates, fires burning on both sides of the road in the neighborhood in the hills of Camarillo.

Before everything turned red a half-hour earlier, she could still see blue sky on the edge of a massive plume of smoke. She moved laundry baskets full of family photos, computers and medications to her car.

Jim Lingl, her husband, pulled out of the driveway on Estaban Drive just ahead of her. They quickly got separated by other evacuees. Up ahead, she could see a burning truck in the road. Some drivers turned back.

Jim had turned around too, returning to their house to try to keep it safe. The smoke was so thick she couldn't see him pass her.

She could feel the heat of the flames as a firefighter told her to stay as far to the left of the truck as she could. They had made room, he told her. She could make it.

"Whatever you do, don't stop," he said. "Just keep going."

She felt like she was hyperventilating. Her dog Bella sat next to her in the car. Thick smoke closed in around them. She couldn't see.

In the next big gust of wind, she spotted someone's taillights maybe 20 feet ahead.

It would still be two hours until she picked up a call and heard Jim's voice. Firefighters had pulled him out and dropped him at the neighborhood fire station. Later still, they would find out their house burned.

But in that moment, she focused on that pair of taillights.

A couple blocks later, traffic stopped, jammed with cars on Valley Vista Drive. A firefighter called out from an engine's speaker, telling people to turn on another road instead.

She turned out of traffic finding a nearly clear route and drove toward the church she and Jim set as a meeting place.

# No time for noodles

It was lunch time at Bernadette's, the residential care and hospice home at the bottom of Marissa Lane in Camarillo Heights. Four elderly residents, all in beds, had just started eating chicken nuggets and noodles.

Sheriff's deputies pounded on the door. Though smoke already filled the sky, a darker patch was coming. The home two lots away from the care center would soon burn to the ground.

"It was like the apocalypse," said Bernadette Abiera, the home's administrator.

Deputies lifted the residents out of their beds and into wheelchairs. They rolled them down a hill to waiting squad cars.

Abiera ducked out of the house with paperwork. The deputies told her the fire was too close. No one could go back inside. Alarmed, she told them not everyone was out yet.

The deputies ran back in to find two caregivers tending to a resident who was still eating his lunch. He wouldn't stop.

"I had to take the food out of his hands and carry him to the wheelchair," said Deputy Justin Lopez.

All four residents were driven to a nearby hospital. One stayed there. The others were taken to a motel in Thousand Oaks.

## **Questions with no answers**

The fire played a horrifying game of checkers, leaping over one home and destroying another.

About halfway down West Highland Drive, the fire ripped through a home with a spiral staircase. The ruins include burned hardbound covers from a children's book written by the home's owner, Fawn Parish. "There Is No Spot Where God Is Not!" it's called.

Near the top of the hill, Donna Herleikson has lived in her home for some 60 years. She started packing late Wednesday morning after being told to evacuate. Then she saw her

neighbor's house burning. Her son told her there was no time to pack. They drove to safety, ending up at a Motel 6.

The fire was everywhere. Herleikson's house wasn't touched. Days later, she sat in her home and said she was blessed. She repeated the words, still trying to make sense of it all.

"We only had three houses on our side survive. The rest were torched," Herleikson said. "I'm so thankful it's still here, but you feel guilty, too. How come you got lucky and your neighbor didn't?"

## Ventura County Department of Airports: Update to Soil Stockpiles at Oxnard Airport



The Ventura County Department of Airports is eager to share with the community that the soil stockpiles currently stored on Oxnard Airport property will be removed from the property and taken to landfills for disposal. Environmental testing for the stockpiles, which focused specifically on PFAS contamination, have been completed and disposal of the stockpiles has been coordinated with the State of California Regional Water Quality Review Board. Non-PFAS impacted soil will be going to the Chiquita Canyon or Simi Valley landfills while soil found to be impacted by PFAS will be sent to the landfill in Buttonwillow (Kern County). Disposal is expected to begin as soon as December 11<sup>th</sup> and will be completed within 60 days.

We'd like to provide additional context and a history of this project. The information below was included in a community notice sent in June 2024.

As noted above, the soil piles are currently on Oxnard Airport property east of Ventura Road (see map image). These piles were associated with a previous airport construction project during which, in cooperation with the State of California Regional Water Quality Review Board, we agreed to temporarily store and test the material before disposal. The Department of Airports continues to work cooperatively with the State of California Regional Water Quality Review Board to delineate the presence of PFAS at the airport, which was recently determined by the federal government to be a chemical of concern and is a chemical found in FAA-mandated firefighting foam. For that reason, we set aside soil excavated from the prior project construction area to allow for testing before disposal.

PFAS chemicals have been used in the United States since the 1950s and are in products such as non-stick cooking pans, dental floss, food packaging, clothes, microwave popcorn bags, laundry soap, carpeting, etc. The article at the link below shares more information about PFAS in consumer products:

These "forever" chemicals are also found in the aircraft firefighting foam mandated by the Federal Aviation Administration (FAA), which was used on two occasions and annually for required testing of fire trucks. It is important to note that no PFAS foam has been sprayed at Oxnard Airport since 2019. To meet federal requirements for equipment testing the Department of Airports acquired a specialized instrument to test the readiness of its trucks without needing to release any foam.

Fire Response and Increase in Aircraft Activity

On behalf of the City of Camarillo, I want to express my appreciation of your Department's ongoing efforts to address the noise concerns of our community, particularly those affecting residents in Old Town Camarillo.

Thank you for your letter dated September 24, 2024, addressing the City of Camarillo's request for consideration of specific items during the Part 150 Noise Study process. We are encouraged by the Ventura County Department of Airport's acknowledgement of the three key items outlined in your letter to the City:

- 1. The prioritization and expediting of an alternative flight path approach and the involvement of local residents in selecting a consulting firm to evaluate feasibility. We are encouraged by the approval of the contract with LEAN/Coffman and look forward to seeing the results of their work in the coming months.
- 2. The consideration of permanent noise monitoring locations and the inclusion of this item as part of the Part 150 study. We support this approach and are confident that this will assist in identifying potential mitigation measures for the area.
- 3. The commitment to continue meeting all State and Federal air quality review requirements as part of airport projects. We understand that CEQA and NEPA reviews are critical to ensuring compliance with air quality regulations, and we appreciate the Department's adherence to these standards.

City staff participated fully participated in the Planning Advisory Committee for Camarillo Airport's Part 150 Study. City staff and elected officials attended the community meeting on October 7 to listen to the presentation and hear feedback from Camarillo residents. On December 4, 2024, staff emailed you an updated City of Camarillo General Plan Land Use Map for inclusion in the pertinent sections of the Part 150 Study to more accurately convey airport noise contours in Chapter 7 of the Part 150 Study, where noise contours are overlain on a land use map. We noted the inclusion of the Joint Powers Agreement as Appendix C in Camarillo Airport's Part 150 Study. In all that you do, we are counting on you to continue to uphold the 1976 Agreement, as committed to in the letter from the County to the City, dated January 19, 2022, and since that time through verbal and written correspondence between the two entities. Additionally, we encourage you to continue engaging with Camarillo residents in all airport-related matters that have the potential to impact quality of life.

We are optimistic that the objectives outlined in Camarillo Airport's Part 150 Noise Study will be achieved, leading to effective noise mitigation solutions for our residents. We value our partnership with Ventura County Department of Airports in planning for the future of this important community asset, and the City will continue to dedicate the time, attention and energy necessary to find a resolution on these issues.

Dear Mayor Trembley,

Let me start by saying that the Ventura County Department of Airports (Department) appreciates the City of Camarillo's (City) constant and continued input throughout the Camarillo Airport Part 150 Noise Study process. I would like to address your letter, dated May 22, 2024, regarding the City's request for the Department to consider the implementation of three items during the FAR Part 150 Noise Study process.

The three items included:

- Prioritizing and expediting options concerning an alternative flight path approach, particularly in regard to Old Town Camarillo and the noise issues experienced by its residents.
   (*I am excited to report that on August 1<sup>st</sup> we gathered an interview panel, which included a resident from Old Town, to select a consulting firm to analyze the feasibility of changes to the Camarillo Airport flight path. Their work will include evaluating other modifications/changes that could realize a noise mitigation benefit to the Old Town Camarillo residents. And today the County Board of Supervisors approved the contract with LEAN/Coffman for \$268,000 authorizing them to begin this work.)*
- 2. Installation of permanent noise monitoring locations in and around Old Town relative to the current flight path approach.

(The installation of a permanent noise monitoring system is something that will be considered during the FAR Part 150 Noise Study as a possible noise mitigation measure. We remain open to the idea of permanent or regularly scheduled noise monitoring to assist with our noise mitigation measures and will be evaluating this item among the entire NCP recommendations at the conclusion of the study. The draft NCP will be shared with stakeholders during our planned October 7, 2024, public meeting.)

3. An appropriate review and study of air quality concerns which have been expressed by residents. (Currently each new airport facility project is required to complete CEQA environmental review. Additionally, all FAA funded infrastructure projects are required to complete both CEQA and NEPA environmental review. The Department of Airports has complied with all State and Federal requirements for air quality analysis for each project proposed at Camarillo Airport and will continue to meet all applicable regulations.) I look forward to discussing these items in further detail over the coming months. Your partnership throughout the FAR Part 150 Noise Study process is key to a successful outcome.

Subject: Notice of Violation Unauthorized Operation 29DEC and 30DEC Camarillo Airport – Exceeded Weight Restrictions

#### Dear

On December 29<sup>th</sup> and December 30<sup>th</sup>, the Boeing Business Jet registered to your company operated in excess of the published runway load bearing limitation and also in violation of the curfew weight restriction of 115,000 lbs. We have enforced this as a restriction on Max Takeoff Weight of the aircraft listed per available registration documents. ICAO records show that the MTOW is 154,500 lbs. When alerted to the violation, your crews mitigated the situation by not taking on fuel and departing at the same weight as you arrived with, which we appreciate.

This curfew weight restriction arises from a Joint Powers Agreement between the City of Camarillo and the County of Ventura, which has been in effect since Camarillo Airport opened as a civilian airport in 1976. The purpose of the restriction was, and continues to be, the reasonable quiet enjoyment of neighboring residents.

The County of Ventura requests that you and your flight crews assist us by not scheduling flight operations at Camarillo Airport with the Boeing Business Jet or other aircraft with a Max Takeoff Weight exceeding 115,000 lbs. Per our discussion this morning, the County would allow operations using the Gulfstream 550 in your fleet.

As also discussed, please also bear in mind that Camarillo Airport is an extremely noise sensitive environment. To that end, there is a hard curfew prohibiting departures between 0000 and 0500 local. Arrivals are allowable during that time but are discouraged under our Fly Friendly program. Crews *arriving* when the tower is closed should make every effort to utilize Runway 8 when safe to do so. Departures should strive to use Runway 26

to avoid overflight of neighborhoods directly to the east of the airport. We strongly encourage all operations occur between 0700 and 2200 local.
